Note from the School District Administrator

School is well underway and off to a very good start as we approach the midpoint of quarter one. Academics, athletics, music, and teamwork have all been on display and once again given us something to be very proud of. Hopefully, you will be able to join us at one of these activities during the wonderful fall weather that blesses the northwoods this time of year.

The process of developing and managing the annual budget is a year round task that finally comes together for the current school year with the annual meeting on the fourth Monday of October each year. This is the time when enrollment, state funding, property valuations, and levy determinations come together to help us finalize an annual budget. This year's proposed budget is built on the following priorities that our Board of Education has continued to endorse over the past several years. 1) Work hard to continue all existing programs and services for students 2) Evaluate staffing needs while balancing costs 3) Pursuing grants to help fund opportunities for all students, and 4) Spend fund balance if needed to balance the budget.

The budget information being presented is a preliminary budget summary until the State of Wisconsin finalizes all budget numbers on October 15. Although this may seem a little like the "cart before the horse", this remains the budget process in the state of Wisconsin. As a result, we have made "educated assumptions" about the numbers with the

preliminary budget summary. By the time we meet for the annual meeting, we will have the final numbers so that the budget and levy can be adopted by the Board after the annual meeting.

Even though we received more in state aid, the district's revenue is limited by the State Revenue Limits. Our budget is extremely tight, with the loss of grant dollars at the state and federal level resulting in additional costs to the district to support established programming. These expenditures can make purchasing large cost capital items from the fund balance a necessity. This was the case in 2017-18, when the district purchased much needed special education equipment and a phone system (due to an outdated, non-supported system). Much more than ever before, the district budget is influenced by items like student membership numbers, open enrollment losses, special education costs, and college options programming.

In spite of the budget constraints, we are cautiously optimistic as we move forward. On the bright side, the elementary school debt is now paid off and the debt levy amount needed to cover the 2015 referendum improvements is considerably lower. The state budget also allocated more state aid, which will help taxpayers due to less reliance on local funds. The district will also receive approximately \$84,000 in School Safety Grants which will allow us to address safety, security, and mental health trainings outside the school budget.

I truly think that the Rib Lake District is a special place to live, learn and grow. Our initial 2017-18 test scores, participation rates, and number of college credits earned by our students attest to this. We have students who represent us very well, whether measured by test scores, success of our graduates or by the character of our students. When combined with the outstanding efforts of our parents and staff, good things happen on a daily basis. The Rib Lake Schools are also the heart of our community due to the support of the district residents. Whether it be volunteering, raising money for our facilities, taking test rides, helping fund scholarships, or supporting school activities, the district residents share a special bond with the school that is not always the case in other districts.

Your views as a stakeholder in the local educational process are valued. Please join us at the Rib Lake School District Annual Meeting on Monday, October 22 at 7 pm as we set the course for the year. The annual meeting allows residents an opportunity to focus on the needs of the district, student achievements, and helping create a vision for our district. I also encourage you to call me with any questions you may have throughout the year concerning school operations.

School Safety

Like all school districts throughout the nation, school safety is at the forefront of our focus. The Rib Lake School District has been working for the past 3 years on the following initiatives to help prevent school threats

- Establishing secure entrances with visitor protocols.
- Focusing on improving building, staff and parental notification communications systems.
- Providing training to the staff and students in the ALICE method of crisis decision making.
- Partnered with the village for school resource officer hours.
- Focusing on mental health trainings, developing mental health and school safety teams, and nonviolent crisis intervention programing.


Energy Efficiency Report

The School District of Rib Lake has been tracking baseline energy use data since the referendum project of 2015. Electrical, gas, water, and wood usage has been tracked using pre-referendum data to current usage with the energy improvements. During the 2017-18 school year, reports showed the district saved \$20,685 in utility costs.
