I want to begin this newsletter thanking you for your involvement in your child's education and for your continued support of the Rib Lake School District. As I start my third year in Rib Lake, I feel truly fortunate to work with such amazing students, staff, families and supportive community.

Rib Lake School District continues to be committed to providing the highest quality of education for every student in a responsive and enriching environment. The 2014-15 school year will bring to fruition various statewide initiatives including Educator Effectiveness, new teacher/administrator evaluations and standards along with competencies based on student growth and achievement, as well as the SMARTER Balanced Assessments (replacing the fall WKCE tests). NEW STUDENTS/NEW FAMILY ADDITIONS

If your family has recently moved to the area and you have a student(s) you would like to enroll in the Rib Lake School District, please contact the appropriate school office to ensure a smooth start for your student.

If you have a recent addition to your family, please contact Neva at 715.427.5446. The school district records all children (along with pertinent information) that live within the district. This information ensures families are contacted when age appropriate school offerings are available for their children.

STUDENT HANDBOOKS

Parents are asked to thoroughly review all information sent home with students on the first day of school. These items will include emergency forms (to be completed and returned), student handbooks, free/reduced lunch forms, accident insurance information, etc. Please take the time to review this information with your student. Handbooks are also located on the website of each school.

STUDENT SUPPLY LISTS

Recommended supply lists for students entering grades 4 year old and K-8th grade for the 2014-15 school year are available at Medford's Wal-Mart & Kmart, by contacting the elementary or middle school office, or by checking the school website. The high school requires students to have pens, pencils, note paper, student organizer or notebooks, and highlighters. Other needed materials are schedule specific and will be discussed on the first day.

STUDENT SCHOOL ATTENDANCE

One of the areas of concern that arises each year is student school attendance. The state and local attendance regulations that the school district is mandated to comply with are outlined in your student's handbook, and are discussed with students on the first day of school. Parents or guardians **MUST** contact the school when their student will be/has been absent. If this is not done, the student will be marked 'UNEXCUSED' which eventually leads to truancy reporting. Parents are also encouraged to obtain verification for any appointments to professionals for their child. Please take the time to review this issue with your student since we are obligated by the state to enforce it. Students in grades K-12 may be excused from school by their parent for no more than 10 days each year and must have a medical/legal excuse for any days beyond this point.

The school feels family outings are very valuable educational opportunities. Anyone planning a family trip must complete a family trip form and return it

to their child's building principal prior to the anticipated event. This will pre-empt your child and request assignment make-up permission. Unless other arrangements have been made with individual teachers, it is required that homework be completed before trip departure or at the latest, upon return to school.

DRIVE FOR SCHOOL

Once again during Ice Age Days on August 8th-10th you will have the opportunity to test drive a new Ford vehicle and in the process earn \$20.00 for the Rib Lake Athletic Booster Club. Medford Motors and Ford will be donating up to \$6,000.00 for any 18+ year old driver who test drives a new Ford vehicle. Proceeds from this event will be used for school district facility improvements. The new vehicles will be located at the corner of McComb and Fayette Avenues in Rib Lake. Vehicles will be available for test drives from 6-9 p.m. on August 8th, 12-8 p.m. on August 9th and from 12-5 p.m. on August 10th.

Thanks to all who have participated in this event in the past. Everyone is encouraged to come out during Ice Age Days and test drive a new Ford vehicle.

FOOD SERVICE UPDATES

The school district will continue to use the automated breakfast/lunch procedures for 2014-15. Due to a mandatory cost increase, full priced meals have increased along with extra milk/juice.

- ❖ *Extra Milk/Juice* = \$.30
- ❖ *Elementary Breakfast* \$1.25 & *Lunch* \$2.40
- ❖ *Middle/High School Breakfast* \$1.60 & *Lunch* \$2.65
- ❖ *High School 2nd entrée (when available)* \$.50

Students eligible for free or reduced lunches during the 2013-14 school year may continue that status for 30 operating days, pending receipt and approval of updated forms from parents for the 2014-15 school year. Forms may be found in this newsletter. Spanish forms may be picked up at any of the school offices.

It is the policy of the district that all students shall have an opportunity to participate in the school lunch/breakfast program. However, those with negative balances of more than \$35.00 will be denied hot lunch access. Such individuals will be served an alternate cold lunch. The only exception would include cases of "extreme circumstances" which are appealed to the District Administrator.

Each family has been issued a "password" to allow access to account balances. Families new to the district will be mailed information regarding their account. If you need assistance with this process, please contact your respective school office.



TECHNOLOGY

The Rib Lake School district has a goal of increasing career and post-secondary readiness through the use of technology. In order to help students meet these new technology goals, computers are available to both middle and high school students outside school hours. To stay abreast of technological changes in the district, be sure to read all information brought home by your child and/or visit the school district web page for updates.

TEXTBOOKS

Textbooks are available to students at no charge. However, if it is determined that a student damages/loses any district owned book during the time it is entrusted to the student, the student/student's family is responsible for the cost of damages incurred or the replacement cost of the book.

Bienvenido

Students should report to their assigned classrooms on the first day of school. Staff will be available for students needing assistance. Parents may obtain information regarding grade level teaching assignments on the school website or by calling 715.427.5818 after August 18th.

Classes will begin every day at 8:20 a.m. and dismissal times are as follows: 4 year old KG—3:00 p.m., grades K-2—3:05 p.m., and grades 3-5—3:10 p.m. Breakfast and lunch meals will be available to students beginning Tuesday, September 2nd. Breakfast is served from 7:55-8:20 a.m. daily.

MIDDLE SCHOOL/HIGH SCHOOL

Students entering grades 6-12 should enter the gymnasium in their assigned building upon arrival to school on the first day of school, Tuesday, September 2nd, 2014. The school day for students in grades 6-12 runs from 8:10 a.m. to 3:20 p.m. Breakfast will be available daily from 7:50 - 8:05 a.m., starting September 2nd.

Class Dues: Class dues will be \$15.00 per year for freshman, sophomores, juniors, and seniors. Class dues should be paid in the High School office. Class dues are used to cover class activities, prom, and graduation expenses.

Middle School Music: All 6th grade students must take part in band or choir (they may take both) to fulfill a music requirement. Students in grades 7-8 have fulfilled this requirement and are encouraged to have music be a part of

their schedule. Any changes to a students' music schedule must be completed by the end of the first week in September. Changes require a note from the parent stating the change and the reason for the change. The teacher and principal will also need to sign the change request before the office can officially change the schedule.

High School Class Schedules and Schedule Change Timeline: Students should receive their schedules in the mail approximately August 8th. Schedule change dates will be on Monday, August 18th from 10:00 a.m. to

3:00 p.m. and Tuesday, August 19th from 10:00 a.m. until 6:00 p.m.

New High School Assessments:

Starting with the 2014-15 school year, Wisconsin High Schools will be changing to ACT based assessments from the Wisconsin Knowledge and Concepts Examination given in past years to grade 10. All students in grades 9-11 will be assessed in English, reading, math, science, and writing. The purpose of having this new ACT testing is to help better prepare students

in their post-secondary choices through college and career planning linked to personalized data. The new tests and procedures will result in the following changes for state testing of RLHS students:
 Grade 9: ACT Aspire exam (fall and spring)
 Grade 10: ACT Aspire exam (spring)
 Grade 11: All Juniors will take ACT exam and ACT Work Keys

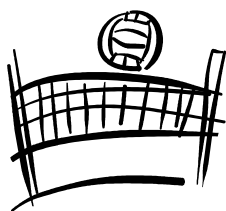
Concussion Pre-Testing:

Concussion pre-testing will be available to all student athletes in grades 6-12 again this year.

Any new or current athlete who was not tested last year should contact their coach or an Athletic Director for more information.

The recommendation is for athletes to be tested every 2 years.

Testing sessions will be scheduled before each sport season.

NOTIFICATION OF ASBESTOS

The School District of Rib Lake completed a comprehensive inspection of district buildings to determine the presence of asbestos containing material and initiatives to eliminate and control the presence of asbestos have been implemented. Some amounts of asbestos conating material remain in district buildings. MacNeil Enviromental testing conducts a surveillance of all sites and the district receives updated reports.

RELEASE OF STUDENT INFORMATION

According to the law, public institutions must provide directory information to individuals that request this information. Therefore, the Rib Lake District Board of Education has adopted a policy which enables individuals to secure directory information. This information includes student’s name, address, telephone listing, date and place of birth, participation in officially recognized activities and sports, dates of attendance, photographs, degrees and awards received and the name of school most recently attended by the student. **If you do not want part or all of this information made available, please put this in writing and submit to the school office no more than 14 days after students start school.**

ANNUAL NOTICE OF SPECIAL EDUCATION REFERRAL AND EVALUATION PROCEDURES

Upon request, the School District of Rib Lake is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child’s parent that the referral will be made.

Others, including parents, who reasonably believe a child is a child with a disability may also refer the child, including a homeless child, to the school district in which the child resides.

Referrals must be in writing and include the reason why the person believes the child is a child with a disability. A referral may be made by contacting Jonathon Dallmann, Director of Special Education, at 715.427.3222, or by writing him at P.O. Box 278, Rib Lake, WI 54470.

RIGHT TO REQUEST A SCHOOL & SCHOOL DISTRICT PERFORMANCE REPORT

Pursuant to section 115.38(2) of the Wisconsin State Statutes, the Rib Lake School Board hereby notifies the parents/guardians of students enrolled in the district of their right to request a school and school district performance report. HEALTH INFORMATION FOR PARENTS

Please remember to fill out and/or update your student's medical information and emergency contacts at the beginning of the year so we can notify you, in a timely manner, of health issues when your child(ren) are at school.

Students may need to receive medication during school hours related to either acute or chronic conditions in order for them to benefit from educational services. Administration of medication by school staff must follow established policy/procedures:

1. Prescription medication (including asthma medication) must be in original bottle/container with current label including student's name, name of medication, dose, and name of physician.
2. A new permission form must be submitted each school year.
3. Non-prescription medications should also be in original container. Only parent/guardian signature is required, unless medication is to be administered other than dosage on bottle. In this case, physician's signature is also required.
