Board President Blomberg called the meeting to order at 6:57 p.m. followed by the Pledge of Allegiance.

Roll Call: Magnuson, Fuchs, Martin, Zondlo, Everson, Rymer, and Blomberg.

Magnuson made a motion to accept the minutes of the December 11, 2014 Regular Meeting. Zondlo seconded. Martin pointed out a mistake on these minutes (Rymer made a motion to pay bills and Rymer seconded) and Fuchs made a motion to accept the amended minutes seconded by Everson. Motion carried by a 7-0 voice vote.

Zondlo made a motion to pay the bills of \$47,917.88. Martin seconded. Motion carried by a 7-0 roll call vote.

Old Business: Discussion/Possible Action with Respect to:

- A. Finalize Energy Performance Savings Projects and Costs Josh from H & H presented, along with input from Chris and TJ with a goal of taking a step toward financing. After discussion, Fuchs stated that the Board needed to "pare down" the list and this was done by a show of hands against each item not considered critical by the Board.
- B. Proposed Technical Excellence Scholarship BP 345.4 (2nd Reading) Everson made a motion to approve this Board policy, seconded by Magnuson. Motion carried with a 7-0 voice vote.

- A. 2013-14 Audit Report Administrator Manion informed the Board that the full report was available for them to read at the District Office and mentioned a few of the suggestions that were made by the auditors.
- B. Certification of Results of Election: RLEA Administrator Manion informed the Board that there were 40 eligible voters for recertification and 33 voted to continue on with RLEA. What this means for the Board is that base wage must stay at or below CPI.
- C. WASB/School Perceptions Survey Administrator Manion informed the Board of this survey that is available for them to take anonymously to evaluate themselves as a Board. She offered her assistance with the technical issues of this online survey and informed the Board that they each have a unique number that they need to use when completing this survey.
- D. Marawood Athletic Conference Officials Pay Increase Officials pay has increased to \$70, \$100 for Volleyball. Mileage 0-50 miles is \$0, 51-100 miles is \$30, and 101 miles or more is \$50.
- E. School Board Elections Stacy Tlusty will be running for Marlene's vacated seat and MaryAnne Roiger will be running against George Zondlo. Steve Martin will run unopposed.

- D. Potential Ratification 2014-15 RLEA Collective Bargaining Agreement Administrator Manion stated that RLEA is not ready to ratify.
